### Hairy Willowherb *Epilobium hirsutum*

- Soft, hairy, semi-aquatic, 3-5 ft. tall
- Blooms late spring/early summer
- Outcompetes natives in wetlands
- Hand dig small infestations, remove all rhizomes

### Purple Loosestrife *Lythrum salicaria*

- Rhizomatous perennial, 6-10 ft. tall
- 5-7 petals per showy magenta flower
- Emergent aquatic plant in wet areas
- Loosestrife beetles (*Galerucella californiensis* and *Galerucella pusilla*), Loosestrife root weevil (*Hylobius transversovittatus*), and Loosestrife seed weevil (*Nanophyes marmoratus*) are biological control agents that feed on various parts of the plant

**Noxious weeds are invasive, non-native plants, which outcompete native plants, due to limited or no known natural biological controls.**

Washington's noxious weed law ([RCW 17.10](http://RCW17.10)) requires landowners, as well as city, county, and state land agencies to control or eradicate certain weeds that occur on property in an effort to maintain the ecology and economy of Washington's landscapes.

### Spotted Knapweed *Centaurea stoebe*

- Biennial or perennial, rough & woolly
- Grows up to 5 ft. tall with stout taproot in pastures, fields, & roadside areas
- Flowers are purple, pink, or white & solitary
- Dig or pull & don't mow except to temporarily stop seed production
